Meeting with Senator Jo Comerford and Representative Mindy Domb – December 8, 2022

NOTES:

- MSBA reimbursement rate (have 3 years of catch up for increases, but appears they will only do 1 year of catch up.)
 MSBA will meet this month. Stopped repair program. Senator Comerford and Representative Domb to follow up regarding reimbursement rate.
- Library/MBCL Funding Timing ARPA funding Anything before October 2023 House trying to get ARPA funds in the next session.

- 3. Timing on filing special legislation actual legislation or placeholders
 - **a.** Refile Ranked Choice Voting We do not need to revote at the Town Council level. This was confirmed with Clerk's Office.
 - b. Tax/Fee on Sale/Transfer of Property Deadline for legislation or placeholders. Because it is a Home Rule it can technically come in anytime. However, the earlier the better so that hearing on Amherst is held at the same time as Boston, Nantucket, Somerville (all of which filed in the 2021-22 session). There is a little east/west difference regarding the price threshold (i.e., Boston wants \$2M which would not help Amherst.) Early is at least April; if house lifts February deadline as they did during COVID, then could be April. They will know about deadline once back in session on January 3.
 - c. Reparations deadline is not as critical because there are no others who are filing.
- 4. Cannabis Regulations and any advice you may have.

The spirit of the law is not to redo the existing agreements although we keep hearing that the 5 dispensaries may not want to stick to that. Amherst wants our existing contracts to be honored. When contracts come up for renewal then it is all back on the table. The bill that came out and was voted on did not have the redo of the existing. Some establishments are withholding payments and Boston and Northampton have stopped collecting fees. Senator Comerford has already weighed in with the CCC. MMA has this as their number 1 priority.

Notes on Background: The Cannabis Control Commission (CCC) will soon begin its process to promulgate new regulations to implement various provisions of the recently passed cannabis law, Chapter 180 of the Acts of 2022: An Act Relative to Equity in the Cannabis Industry.

The MMA has written the following:

Protecting Existing Host Community Agreements and Moving the Industry Forward Cities and towns led the way in deciding whether to open neighborhoods to commercial marijuana enterprises and have negotiated in good faith to execute host community agreements (HCAs), including mutually-agreed-to provisions on community impact fees. More than 1,000 such contracts have been put in place, establishing the platform for growth of the industry in Massachusetts. While constitutional tenets protect existing contracts from statutory encroachment, the process outlined in Chapter 180 has opened the door to interference in these properly executed HCAs by licensees and special interests in the cannabis industry. As the CCC moves forward in the regulatory process in relation to HCAs within the context of this new law, MMA is strongly urging a two-tiered approach: one for renewal of existing HCAs, which were negotiated in good faith and are protected by the Contract Clause of the Constitution, and one for the licensure and renewal of new HCAs, executed after the new law's effective date. This would move the industry forward by avoiding statutory encroachment of existing HCAs, prevent extensive legal challenges, and match the intent of legislators by holding municipalities and their taxpayers harmless.

- 5. PILOT Legislation separate efforts for public and private IHEs; how is state land determined for appropriation; urged factors such as the development of the land or the effect on Town services. MMA is interested in this. We will continue discussion in January.
- 6. Amherst is buying a site for a permanent Homeless Shelter Former VFW Main Street just down from Town Hall; approximately 1 acre; used ARPA funds to buy the land so it is town-owned; received approval up to the state level of VFW; agree it will include some veterans; concept is that it will be Day, Overnight. Just the first step. Senator Comerford stated that this was really extraordinary. There is a large shelter in Northampton and we should connect with them.
- 7. Options for municipalities with CPA funds, mentioning projects to mitigate or respond to climate change.

Last year, Representative Domb explored the question with CPA organization regarding another category of funds. The CPA state organization and legislation were formulated with three original stakeholders. Politically hard to add a category. If the Town is interested in grants regarding climate issue that should continue to apply for MVP program – which we have and received several. Could also be in the upcoming Climate Bill.

- 8. How charter school tuition or other tuition is determined. Our legislators are trying to fully fund the Charter School reimbursement rate. The old administration was not willing to open this up. Hope the new administration will and also cap the number of charter schools.
- 9. Reimbursement for Special Education tuition in. *Western Mass legislators have been discussing the special education formula which is really broken. Will be submitting various bills. Will need major advocacy.*
- 10. Millionaire's tax Do not have a handle on this yet. Will need to make sure Western Mass gets its share. How will it be distributed grants, allocations, etc.?
- 11. Setting a date for talking about our 2023 Priorities January meeting.
